



alpha-En Corporation Signs Lease for New Product Development Center and Corporate Headquarters

The facility is conveniently located in the revitalized downtown section of Yonkers, with convenient access to all New York airports as well as New York City via the Metro North and Amtrak rail lines.

“We are thrilled to have alpha-En with its clean energy technology at iPark Hudson.” Said Joe Cotter, President of National Resources, parent of the iPark development. “alpha-En brings the "creative class" workforce that is the gold standard for job creation.
